SUMMER CAMP OPTIONS INCLUDE DAY CAMP (AGES 5-12) AND KIDDIE KAMP (AGES 3-5). DURING FISCAL YEAR 2023, THERE WERE MORE THAN 3,900 REGISTRANTS FOR THESE PROGRAMS.
